- The Owner shall, during the term of this agreement, pay the Trainer as follows:

- It is agreed that the horse will be entered in the name of the Owner and handled in the name of the Trainer.
- The owner releases the trainer to haul the horse to venues of the trainers choice for training, schooling, vet or farrier purposes.
- In the event the horse becomes ill or in need of major medical or hospital attention, the Trainer shall care for the horse to the best of her professional knowledge and notify the Owner by telephone to provide information or for instructions.
- Either party may terminate this agreement by notifying the other in writing.  The Trainer shall return the horse to the Owner or to his/her agent and in accordance with the instructions or the Owner (or)  The Owner will pick-up the horse at an agreed upon time. In either case the Owner will pay to the Trainer the amount due at that time.
- All prize money shall belong to:  Owner  Trainer, and the ribbons and trophies shall belong to the Owner.
